Using the Website

The UGS HBB uses the website as an online portal for membership and event management. It also provides entry into our events. Below is a short guide on how to use the new online portal. We welcome constructive feedback so we can improve the user experience. Please read the sections below carefully.

User Registration

Existing members will not need to create a new portal account, your username will be your recorded email address. You should have received an email from the system with these instructions. If you did not receive this email, check your spam folder. If you are unsure which email we have in our records, contact us via the support options listed below in the "Need Help?" section.

If you need to register a new user account, click on the <u>LOGIN</u> menu item above and complete the **USER REGISTRATION** section.

Membership

User registration does not constitute membership. Membership should be applied for by following the instruction on the <u>MEMBERSHIP</u> page. Our events are open to non-members; therefore, membership is not mandatory.

Updating Your Details

You must **LOGIN** with your portal user to access your profile details.

You can view your account details on the **PROFILE** page which can be found in the **MEMBERS** menu. Please ensure your details are accurate and maintained. Only you and system admins can see these details. Your details will never be shared.

Note: your email address is also your login name, you can change that at any time from the **<u>PROFILE</u>** page.

Adding Dogs

In order to enter events, you must add your dogs to the system; this can be done from the **PROFILE** page, which can be found in the **MEMBERS** menu. At the bottom of the **PROFILE** page click the **ADD DOG** button and enter the required details.

Note: It is important that you maintain your dog's qualifications, as this will be considered during event draws.

Entering Events

To enter events, you must **LOGIN** to the portal.

Events can be entered through the EVENTS & RESULTS menu item.

Choose the desired event from the list and click the **EVENT DETAILS** button. You will be presented with the main Event Page, divided into TABs (Schedule, Entries, Draws, Results). You can enter the event on the **SCHEDULE** tab, using the **ENTER EVENT** button. The other tabs are self-explanatory.

Withdrawals: If you need to withdraw from an event, please contact the appropriate events secretary.

Substitutions: If you need to substitute your dog at any time please contact the appropriate events secretary.

Note: The event system is "Dog Owner Specific". That presents some limitations with respect to managing other people's dogs.

- Dogs added to a user account assume <u>that user</u> to be the dog owner, and will be recorded as such in all documentation.

- Dogs can only be entered into events by the user account to which that dog is added.

- If you manage other member's dogs, you will need to maintain one user account for each of those members.

- All automated notifications will only be sent to the user email address.

Reset Password

Your first login will require a password reset, do that on the <u>password reset</u> <u>page</u>. Make sure the field does not include any blank spaces before or after your email address.


We've had another successful year for the Working Test season with all the tests going well.

Thoughts from the podium...

A chance to hear a sampling of the thoughts of a few of the all-weather, all-terrain entrants who shone on their days:

Michael Crutchley with Mitforton Teal – 1st Place Open Qualifier

17th March 2024 at Easneye Estate

"Easneye Estate, near Ware, home to the Buxton Family is a fabulous venue for testing dogs, boasting a mix of terrain; varied woodland, large stretches of open fields with a small river running through.

Teddy, a 3 year old yellow Labrador, has been slow in growing up. Having only recently qualified out of Novice he'd picked up a CoM in his first Open outing, and so I was fairly confident we wouldn't disgrace ourselves. Just looking through the running order though, it was clear that we were stepping up a grade. So we arrived with the attitude it'd be a practical training day with a chance to brush up on our communication skills! He'd be doing all the work, with me on hand to back him up. The tests were the best I've seen in 25 years of mucking about with retrievers, testing the dogs' marking and distance, with quite precise technical handling required to test the drivers.

We started in the woods with Lesley Crompton judging a blind and a mark across a wide ditch and over rough terrain through quite a bit of brash. Some of the dogs running in our group



seemed to struggle as we could hear a lot of whistling. Not knowing what to expect, we managed to get away with it and I hardly had to touch the dog. It was the same on the next test with Jennifer Thomas. Two marks with no shot at right angles in undulating woodland involved precise directional handling. Teddy's honesty with the stop whistle made it look easy. We were starting to enjoy ourselves! Nick Clitheroe's 4 dog walk up was very challenging. We were last of the four to go – the previous three dogs having a blind to shot off the right end of the line followed by a very long memory ahead.

There was a lot of handling from one of our running partners and I felt that at any moment all would be lost with such a young and green dog – but Teddy kept his head and steadiness, before polishing off his two retrieves in great style.

Last test was with Joy Venturi-Rose. Two massively long marks to shot at right angles. The first mark I could hardly make out in the distance and there was no time for the dog to register the fall, because we had to turn swiftly to our left to clock the second mark about 200 yards out, over the river. The bunker was the shot echoing off a building 50 yards to the right; so the trick was to point the dog's head at the area of the fall. Once over the river he ran slightly off-line and I had to step in and burn a point or two, then back to the distant memory which was nailed without any fuss.

I felt Teddy had run his little socks off on the day, and so I was thrilled beyond words to discover we had not only won, but qualified to run in the UGS Area finals – a real honour. I was truly excited about representing HBB in the finals only to be disappointingly struck down with Covid three days before the event. For now I'd like to thank Harriet and all the team at HBB for running such a remarkable and enjoyable day's Test for both dog and handler and look forward to more next spring."

Marianne Copp with Easthoath Benedict – 1st place Novice

21st April 2024 at Cuffley

"A lovely day for a working test, warm enough for the handlers and not hot for the dogs, we were welcomed by Harriet and introduced to the judges, Jo Rollinson Andy Cooper, Steve Coxell and Roy Jarman, and off we set... Basil's first test was walk up, which he managed, just, dropping five marks for his very best heel work! Redeemed by good marking and retrieving. Second test was two very long marks, picking the first one first, both becoming memories, which he managed well.

Our third test was water, really interesting questions for handlers and dog. A mark was thrown on to the water, over a ditch, through long reeds and no vision of it landing. Dogs were sent and handlers could only hope that they kept going in the right direction and had the confidence to pick off the water when they got there, all out of sight. Seemed to take forever, but back he came from the right place with his dummy. The last test for us was a long mark at the top of a hill, before which we were asked to pick a blind at an angle of about 30 degrees from that line to our left, over a ditch, in long grass, about 40 yards away. One stop whistle, left handle, pick, no problem, nobody more surprised than me, and then pick the mark, which had become a very long way away, needed a little handle when he got to the top of the hill and picked.

I was delighted with his behaviour all day and really surprised and grateful to the judges and to the club and brilliant helpers for a super day and a win!

Big thank you to the Cuffley Estate and to Dave Thomas for having us all there and to Harriet for all her hard work, and to her wonderful helpers, who made the day run like clockwork. Basil turned from Naughty Basil to Darling Basil overnight, however it's still work in progress!"

Cynthia Thackwell with Anningtonbay Loyal – 1st place Puppy

7th July 2024 at Rickneys Training Ground

This was a nice puppy sized walk up, one dog, bit of heel work and a mark.

Lovely puppy tests, encouraging the pups but asking a few questions too and I couldn't have asked for more from my little girl as she got full card of 20s! Not a bad start as our first venture out together.

Thank you to all my fellow competitors for the friendly encouraging atmosphere and camaraderie. It was a truly lovely day and one I will remember for a long time indeed. Our first win together.

7th July 2024 at Rickneys Training Ground

"On Sunday 7th July Ben and I were very fortunate to be able to run 4 of our dogs at at UGS HBB working test held at the wonderful Rickneys training ground in Hertfordshire. I ran my 3

year old homebred bitch Colquite Mary Poppins of Blackenvoy in NDNH and her 17 month old daughter Blackenvoy Tenacious Dee in Puppy. Ben was running Dees two siblings also in puppy, Blackenvoy Revelry and Blackenvoy TicTac.

This was my first season competing in working tests, having spent the past 15 or so years enjoying working my dogs picking up on shoots all over the country and generally not worrying too much about the finer details. Ben however really enjoys competing so to show support and solidarity to his passion I decided to have a go at a few tests and this was my 4th attempt at a NDNH with my little dog.



I have to say my first few tests were not especially enjoyable, I was wracked with nerves and felt that Mary and I could absolutely do better despite being placed each time.

With dogs I think you really do have to take the rough with the smooth and people always say that you need the luck to be with you on the day as well as putting the time in. Well today was the day for Mary and me, the tests were challenging but very fair and having got to the end of the day I knew we had done pretty well. More importantly I had finally enjoyed my day, knowing that we had done everything to the best of our ability with no obvious bloopers. The previous failed attempts in the end were in hindsight helpful, they taught us so much and each time we went off and worked on ironing out the creases that had been highlighted by previous competitions, coming back with a little more confidence in our abilities at each test.

7th July 2024 at Rickneys Training Ground

"There weren't that many Opens left by July so I took Amber for a run out all the way from West Sussex for the HBB Veteran at Rickneys in Hertfordshire, to get me out of gardening.

The tests were set at a perfect level for the puppies, novice handlers and veterans. Not too tricky or too far; fairly basic stuff both to test the puppies' level of training and to entertain the older dogs.

Judges were Josefine van der Dussen, Glynis Hillier, Sam Davis and Jacqui Crew. Josie judged two dog walk up with a single mark; Glynis a mark followed by a blind at an angle in rough ground under a tree; Sam gave us a mark along a straight track followed by a blind in the same area, and we finished with Jacqui's test, a blind behind a fallen log followed by a memory mark over a small stream.

Each dummy retrieved was marked out of 20, making a possible total of 140, and everyone went home with plenty of points and happy memories - great encouragement for those new to the circuit.

Amber sailed through the event, only dropping a point at Sam's test – caused by her handler's unnecessary use of the stop whistle. I won't repeat the lame excuse I gave the judge. Amber's the sort of dog that needs minimum handling and after 10+ years I still haven't got the message.

There were plenty of helpers in Harriet's team to ensure the day ran smoothly and I can recommend to anyone wanting a super fun day out in great company to enter next summer's Tests."

Again, the guns shot well despite the low winter sun which made it difficult to see the birds coming.

Drive over and the judges set about picking the birds which had dropped into a belt of woodland and on the grass around the gun pegs. Four dogs were sent in order, to pick a bird in the wood with only the fourth having a find, thus eyewiping the first three. This left just two dogs in the trial both needing retrieves to complete the third round. The judges then tried both dogs on a partridge that had fallen on the grass in front of the gun peg. Sadly, neither dog was successful with the judges going forward and finding it exactly where the marker told them it had landed.

This is a friendly family shoot, and we were blessed with, not one but two keepers; Phil Congreve and Andy Freeman. They, together with a big band of beaters and helpers, run a tight ship, putting plenty of birds in the air for the guns to shoot with superb precision. The first drive saw the guns lined out with their backs to the lake and a mixture of pheasants and partridges dropped along the lake margins, in the water and on the island.

As is quite common nowadays with driven trials, the judges elected to use the odds and evens system. Drive over, and the judges set about selecting

appropriate retrieves for each of the dogs. It became apparent that those birds in the water were proving a challenge for most of the dogs, and very quickly we were down to just two dogs remaining in the trial. The judges sent one of the dogs for a bird that had dropped just on the edge of a cover crop, but it failed to pick, with the second dog duly eye-wiping it. The last dog standing required one more retrieve to complete the 3rd round and was taken round to the other side of the lake and asked to pick a bird on the very edge of the water under the overhang of a tree. I am happy to say it succeeded and looked very smart doing so, and the judges declared the trial over.

A big thank you to all my helpers on the day, judges for their hard work, the keepers and their team of beaters and the Guns for their superb shooting.

As the trial was completed in one drive, our hosts asked if the competitors wanted to pick up on the next couple drives before we went back to yard for lunch and presentations. Most people duly complied with some staying to pick up on the remaining drives after lunch.

Definition of Working Tests

To be in conjunction with UGS and Kennel Club GWT Regulations

Novice Dog/Novice Handler: (unclassified)

Neither dog nor handler to have won any award, including unclassified certificate of merit at a Field Trial, or 1st, 2nd, 3rd, 4th or COM in an Open Working Test, or 1st in ANY test.

Special Puppy: (unclassified)

Open to any dog less than 2-years old on the day of the test.

Puppy:

Open to any dog less than 18-months old on the day of the test.

Novice:

Any dog of any age not having won: a Field Trial award including a COM; a 1st in a Novice Test or any test above Novice level.

Intermediate: (unclassified)

Graded between Novice and Open. Any dog of any age not having won a 1st in any Intermediate or Open Working Test or 1st, 2nd, or 3rd in a Field Trial.

Open:

Open to all dogs although preference in a draw will be given to branch members and dogs who have qualifications making them ineligible to run in any other category test.

Veteran: (unclassified)

Open to all dogs aged 8-years or over on the day before the test.

Young Handler:

Any person under the age of 16 at the time of the test.
